#### About the team

The Policy business group serves as an integrated, professional, and thought-leading advisory group to the government. They are responsible for oversight and stewardship of the regulatory management system. This includes key advice on maintaining and enhancing the statutory and regulatory frameworks that govern the system (including expert economic advice), oversight of Regulatory Impact Analysis and quality assurance and expert advice on new regulatory proposals.



## About the role

The Economist is responsible for delivering high-quality economic analysis and advice that supports the Ministry's core operations. They will:

- Analyse quantitative and qualitative data to shed light on the quality and effects of regulation
- Critically read and review academic and policy research and combine it with various analysis to form opinions about areas with regulatory issues
- Bring economic theory to the analysis of industries, markets, and regulatory systems
- Collaborate with internal teams and external partners to evaluate policy
- Contribute to the Ministry's long-term strategy.

The role may require the ability to obtain a NZ Government National Security Clearance.

- A broad base of economic knowledge, with the ability to apply economic principles and insights across a wide range of regulatory domains, and the willingness to proactively contribute across the Ministry's functions
- Ability to critically evaluate economic literature and quantitative evidence, especially relating to policy design and the impact of economics, law, and regulation on productivity, competition, and economic growth
- Ability to analyse complex data and a sound understanding of the practice of conducting microeconomic research
- Excellent written and verbal communication skills, with a proven ability to clearly and persuasively convey complex economic concepts and findings to non-economists, including policy professionals, lawyers, stakeholders, and leadership
- Excellent analytical and problem-solving skills with a keen attention to detail
- Ability to manage and coordinate a high volume of work in a dynamic environment
- Strong interpersonal skills and the ability to work collaboratively in a team environment.
