Thank you for your Official Information Act 1982 (OIA) request received on 29 May 2025. You requested:

*We note that the construction industry had 107 submissions to date – the highest of any industry. Is it possible to get a breakdown of the 107 construction submissions to date by theme?*

### **Information released**

As you are aware, the Ministry for Regulation (Ministry) reports quarterly on the regulatory issues received<sup>1</sup>. Individuals and organisations that make submissions through the Ministry's Red Tape Portal self-select the industry sector for their submissions, while key themes are identified by the Ministry for some submissions. This information is available in the Microsoft Excel file (tab '2\_KEY\_THEMES') on our website, at the link you referred to in your email, and linked as a footnote below.

Of the submissions where the construction industry was selected by submitters, emerging themes that the Ministry has identified are:

- Building consent
- Fire safety
- Health and safety
- RMA
- Traffic management
- Zoning.
