Thank you for your Official Information Act 1982 (OIA) request received by the Ministry for Regulation (Ministry) on 23 July 2025. You requested:

The attached spreadsheet (**Appendix A**) details all submissions received to 28 July 2025, broken down by date and a theme where applicable. Currently, Ministry officials manually add theme tags during the screening and triage process when a pattern of issues has been identified. For example, we have received multiple submissions related to various traffic management issues, which now have a “Traffic Management” theme tag.

Any relevant themes are shown in column D in the spreadsheet. “General Feedback” refers to general feedback about the Ministry or the Ministry’s work. Please note that some submissions do not follow a specific theme or fall into a specific sector. Additionally, due to the way we currently tag submissions, not all submissions have been categorised with a theme or sector. In instances where this occurs, column D of those items is left blank.

You may be interested in a report recently published on the [Ministry for Regulation website](https://www.regulation.govt.nz/about-us/our-publications/red-tape-submissions-quarterly-report-202425-quarter-4-1-april-30-june/)<sup>1</sup> which includes the top red tape themes received through the tipline, and a high-level breakdown of the outcome of submissions. We plan to continue publishing this information on a quarterly basis going forward.
