Agricultural and Horticultural Products Regulatory Review

For information

On 27 February, joint ministers announced Cabinet decisions and the publication of the Agricultural and Horticultural Products Regulatory Review's (the Review) Report. Media coverage has been consistently positive and has reflected the sector's reactions. In general, the sector has welcomed the Report's recommendations barring one relevant to cost recovery under the Hazardous Substance & New Organisms Act 1996, which was expected.

Early Childhood Education Regulatory Review

For information

Following your agreement to the draft Early Childhood Education Sector Review Cabinet paper, the Ministry will commence agency consultation on 7 March. Agency consultation will run concurrently with Ministerial consultation both ending on 13 March. The final Cabinet Paper is due to be lodged on 20 March for the Expenditure and Regulatory Review Committee (EXP) on 25 March.

In addition, we are working with the communications teams from Ministry of Education, Education Review Office and Ministry of Health to develop a communications approach for announcement following Cabinet approval.

This week we have provided you with the draft findings from the hairdressing and barbering regulatory review, which we are continuing to synthesise with engagement findings and the results of our desktop analysis (MFR2025-043). Note the briefing does not provide advice about a recommended option. We will recommend a preferred option in the Final Report of the Review, which we will provide to you on 27 March 2025.

Regulatory Response / Red Tape Portal

For information

As at 6 March 2025, the Ministry has received a total of 640 submissions on red tape issues. After an initial influx of submissions following the launch of the portal last year, the submission volumes appear to be stabilising. We have received 147 new issues in 2025, with 62 and 71 submissions through the portal for January and February, respectively. The average submissions received per day this year remains steady, between 2-3 per day.

Following your press release on 1 March which referenced the 'Red-Tape Tipline', we have received some new media interest in the red tape portal including requests for portal statistics such as themes.
