Updates

Regulatory Standards Bill

For information

This week we provided a revised Cabinet paper on Wednesday for lodging for Monday's Cabinet meeting.

Waitangi Tribunal grants Regulatory Standards Bill urgency application – Wai 3440

The Tribunal has granted the application for urgent inquiry into the RSB claim, with a one-day hearing on Friday 6 June. This decision does not affect the government's ability to introduce the RSB at any point, **s** 9(2)(g)(i)

The next Crown steps in the inquiry are lodging the RIS and TIA within 48 hours of Cabinet drafting approval, then lodging Crown evidence by Wednesday 21 May. The inquiry is limited to whether either the process for developing the content of the RSB or the consultation process were a breach of the Treaty.

As at 28 April 2025, the Ministry has received a total of 704 submissions on red tape issues, with 97 issues under active investigation.

We provided your advisors with an overview of the next quarter's reporting on 30 April. We will be providing you with an aide-mémoire next week with high level information on the Q3 reporting. We will then be incorporating any feedback on the draft report and publishing that information on our website in early May, including highlights of key pieces of work completed in the last quarter.

On 29 April, your joint press release with Minister Brown on the \$90million economic opportunity from Advertising at Medical Conferences was released, and was warmly welcomed on social media by BusinessNZ CEO Katherine Rich, and received coverage in trade media.

Targeted engagement on the draft Terms of Reference (ToR) ended on Monday, 28 April 2025. You and Minister Goldsmith have been provided with an updated ToR along and a draft Cabinet paper.

Following a request from Ministers' offices regarding the timeframe, the paper is now due to be considered by the Cabinet Expenditure and Regulatory Review Committee (EXP) at its meeting on Tuesday, 20 May 2025. Ministerial and agency consultation, subject to joint ministers' approval is due to occur between 7 and 14 May.

Early Childhood Education Regulatory Review

For information

There has been a strong media response following your post-Cabinet announcements last week.

Broadly the sector welcomed the recommendations and was encouraged to see action to remove compliance costs and address long-standing issues such as clarity of roles between regulators.

Concerns, particularly around consultation, centred on recommended licensing criteria revisions and flexibility of qualification requirements.

The Ministry of Education (MoE) will undertake consultation as part of their response and implementation of the recommendations.

We are continuing to work with MoE in relation to Recommendation 9: Revise licensing criteria to ensure they are proportionate, effective, and support quality without overburdening providers. MoE are carrying out further analysis on each of the licensing criteria, as we recommended, and have shared their findings with us.



As MoE drafts new wording for licensing criteria, we will continue to provide feedback where the wording is not aligned to the intentions of the recommendations.

We have worked with your office and across agencies to address your feedback on the draft Cabinet paper.

We understand that the Minister for Food Safety has requested the addition of further proposals into the Cabinet paper, with this to be developed in parallel to ministerial consultation on the paper.

An updated copy was sent to your office on 30 April for ministerial consultation between 1 to 6 May 2025. We are undertaking departmental and Parliamentary Counsel Office consultation in parallel with ministerial consultation, with the aim to lodge the paper on 8 May for Cabinet Economic Policy Committee (ECO) consideration on 14 May 2025.
