Public Service Census Results - Embargoed Until 8 July

For information

Te Taunaki Public Service Census is a survey of New Zealand public servants working in departments and departmental agencies.

The 2025 Census ran from 3-21 March. It covered employee experiences and demographic information, giving valuable insights about capability and culture across Public Service organisations. This is the second public service census, with the first being held in 2021.

The Ministry had an excellent response rate of 98.9% (90/91 responses).

Overall, we are really pleased with our results which show:

- A high level of engagement
- A culture of integrity, innovation and productivity
- That we care about providing value for taxpayer's money
- A respectful culture where people feel valued and can be themselves

The Public Service Commission has directed agencies to develop an action plan reflecting the results. The Ministry's draft action plan is attached in **Appendix 1** which includes two focus areas.

The results, as well as our draft action plan, will be released to our staff in line with the public release of census results by the Public Service Commission on 8 July 2025. Our action plan will be finalised following feedback from staff.

Regulatory Systems Amendment Bills - Guidance under development

The Regulatory Stewardship team is preparing guidance on how agencies can use Regulatory Systems Amendment Bills (RSABs) to repair their existing legislation stock. RSABs are 'clean-up' omnibus bills that update and maintain laws to keep them fit for purpose. Recent RSABs have focused on reducing red tape, improving efficiency and providing time and cost savings for regulated parties. These bills will become more important as agencies undertake consistency assessments on their legislation stock after the RSB is enacted.

Currently, RSABs aren't formally acknowledged by any guidance, standing orders or cabinet circulars. This ambiguity means that agencies only use RSABs sporadically (or not at all). When we last updated you in November 2024, we were meeting with the Office of the Leader of the House, PCO and regulatory agencies, who have since indicated their strong support for guidance in this area.

We are now well underway drafting guidance, which draws on best practices and efficient approaches. This guidance will support effective RSB implementation by promoting RSABs as a tool to maintain legislation stock.

Guidance is planned for launch in October. We will reach out to your office to provide an update on the draft guidance and to discuss further engagement with the Office of the Leader of the House and Office of the Clerk.

Hairdressing and Barbering Regulatory Review

For information

Last week the Cabinet Legislation Committee (LEG) authorised submission of an order to revoke the Health (Hairdressers) Regulations 1980 to the Executive Council. The revocation will come into force on 31 July 2025, 28 days after we expect the Order in Council to be gazetted.

The draft public health guidance for hairdressers and barbers has been reviewed by sector representatives and experts and has now been passed on to the Ministry of Health to go through their sign-out process. There has been a slight delay in completing this due to late feedback from sector groups, and an iterative process that followed involving the infection prevention and control expert and further questions to sector contacts. This delay is likely to impact the timing of

publication of the guidance by the Ministry of Health (originally planned for 10 July, three weeks before revocation), but the guidance will still be available before the regulations are revoked.
