### **Product Labelling Review**

On 21 July 2025 Cabinet agreed for product labelling to be the Ministry's next regulatory review. We provided you last week with a forward plan and engagement approach to the Terms of Reference (MFR2025-191).

The Product Labelling questionnaire went live on 30 July 2025, and the link has been sent to our stakeholders. We are in the process of scheduling and meeting with targeted regulated parties and industry groups.

### **Regulatory Response Team / Red Tape Portal**

As of 29 July 2025, the Ministry has received a total of 834 submissions. We currently have 37 investigations underway (relating to 125 public submissions). We have closed 644 submissions and have 65 submissions awaiting closure or investigation.

#### Q4 and FY24/25 reporting

We have published our Q4 and the FY24/25 full year statistics for the Red Tape Portal on the Ministry's website<sup>2</sup>. This reporting includes insights and data on:

- the overall number of submissions we have received
- the key themes and industry sectors of submissions
- a summary of what we have done with each submission (including referrals)
- demographic information on submitters.
