### **Regulatory Standards Bill**

For information

We have initiated engagement with agencies for the purposes of identifying legislation that may be suitable for exemption from the RSB, via the issuing of a Notice.

This is in line with the proposed approach set out in MFR2025-252 Regulatory Standards Bill - revised process for developing advice on exemptions. The approach, in summary, will involve:

- Engaging with agencies to identify possible exemptions during October, with reference to the framework contained in MFR2025-235 Regulatory Standards Bill - Proposed framework for considering exemptions;
- Subsequent to agency engagement, providing you with advice on possible exemptions;
- Subject to your decisions on this advice, drafting a Cabinet paper seeking approval for the contents of an initial Notice, with agency and Ministerial consultation on the draft Cabinet paper occurring after Royal Assent of the Bill.
