#### **Early in Careers Recruitment Update**

The recruitment and selection processes for our internship and graduate roles has now concluded.

We have appointed four summer interns through two existing public service internship programmes. Two have been appointed through the Analytics and Research in Government (ARG) programme (coordinated by the Ministry of Social Development) and two have been appointed through the Tupu Tai policy internship programme (coordinated by the Ministry of Business,

Innovation and Employment). The interns will join us for 11 weeks beginning in mid-November. The interns will be joining three teams:

We have also appointed five graduates as part of our inaugural graduate programme.
