Updates

Annual Report 2024/25

For information

The Ministry has completed its first annual report. The Ministry's Annual Report 2024/25 was submitted to your office this week for presentation to the House of Representatives (MFR2025-280). The Ministry was exempted from preparing an annual report last year due to its initial establishment phase. Therefore, this year's report covers the period from 1 March 2024 to 30 June 2025.

The Annual Report is required to be presented to the House of Representatives by 21 October 2025. Once presented, our statutory requirements under the Public Finance Act 1989 will be met.

The Annual Report includes an unmodified opinion from Audit New Zealand. The Audit Report gave the Ministry one of the highest ratings possible, with two minor areas for improvement, both of which have already been resolved.

Audit New Zealand noted that "The annual report, in our view, is comprehensive, well balanced, informative and provides a fair representation of the Ministry's activities, achievements and financial results for the 16-month period. The Ministry prepared well for the year-end audit and worked in a collaborative manner with the Audit Team. This helped improve the transparency, understandability, and usefulness of information as presented in your annual report".

You will shortly receive a letter from the Office of the Auditor General to formally inform you of the audit result.

Regulatory Standards Bill

For information

Reporting on obligations under the International Covenant on Civil and Political Rights (ICCPR)

New Zealand is required to regularly report to the United Nations on how our human rights obligations under the ICCPR are being fulfilled. The Ministry of Justice is currently preparing New Zealand's next report which is due in April 2026.

The United Nations has provided a list of matters for the report to address which includes the expected impacts of the Regulatory Standards Bill (RSB) on article 25 of the ICCPR – right to participate in public life. The Ministry of Justice has drafted this section using publicly available information and explanatory material about the RSB that has been prepared previously. *Next steps*

We are currently reviewing the draft report with departmental feedback due by 27 October. The report will then be finalised for ministerial consultation with a draft Cabinet paper seeking agreement for public consultation on the report later this year. The report will be finalised early next year.

Early Childhood Education (ECE) Review

This week we provided you with advice on the ECE Review licensing criteria and attended Ministry of Education's (MoE) agency meeting with you, as Associate Minister of Education to discuss this. A way forward has been agreed, and we understand that MoE is updating its briefing to you to reflect the changes discussed.

Following your direction that the Ministry for Regulation should lead the December 2025 report back to the Cabinet Expenditure and Regulatory Review Committee on the implementation of the review, we met with MoE and the Education Review Office (ERO) this week to discuss the approach. We have requested documentation from both agencies which will inform our report back. We expect to hear from them by close of business 17 October. Following that, we will begin drafting the report and circulate it for MoE and ERO's initial thoughts.

Hospitality Review

On Wednesday, 15 October the Hospitality Review was announced, and the terms of reference were published. Engagement with stakeholders continues. We have met with local hospitality businesses in Wellington, as well as the Food Truck League (the peak body representing food

trucks) and Clubs New Zealand. We have further meetings lined up for the coming week, including with the New Zealand Specialty Coffee Association.

Now that the Review has been announced and the engagement material is live on our website, we will increase our engagement with the sector. This initial engagement period closes on 12 November 2025. We received a submission regarding \$\frac{s}{9(2)(f)(iv)}\$ and have received 39 submissions to date.

We have also set up the Senior Officials Group, comprised of representatives from MBIE, Ministry of Justice, and Ministry for Primary Industries. The group will meet monthly, with the first meeting scheduled for the end of this month.
